East and West EDITORIAL GUIDELINES FOR CONTRIBUTORS

Authors are responsible for obtaining permission to reproduce materials subjected to copyright.

Submission Requirements

Times New Roman font should be used.

Articles should be submitted digitally as Microsoft Word documents (not as a pdf) and as a pdf if special characters are used in the text.

Figures and Plates

Line drawings and photographs are to be numbered as Fig./Figs., and each one should be referred to in the text. Figures should not be embedded in the text but given as single tif, jpg or png files. For photographic images high resolution scans (at least 300 dpi) should be given.

Abstract

Each article should be accompanied by a short summary in Italian up to 200 words.

Formatting and Styles

Accepted formatting: italics, superscript and subscript. Bold and underlined will be removed.

Please use the standard MS Word styles without modifications. "Normal" for body text; "Footnote Text" for footnotes and "Footnote Reference" for footnote references.

Use the long hyphen '—' without spacing inline (e.g. 'Grave goods—potwares, weapons, necklaces—were recovered in the tomb').

Quotations

For inline quotations and translations use "...".

Block quotations and translations: do not use quotation marks.

A translation should be provided for all passages in Greek, Latin, non-Roman alphabets and character-based languages running to more than a few words.

Dates, Page runs, Units of Measure

Dates and page runs should be retained in full (e.g. 1980-1985, not 1980-85, and 250-275, not 250-75). The character between dates and page is an ordinary hyphen '-'.

Dates should be in the format as for example 3500 BCE, 500 CE. Where BP dates are provided calendar dates should also be included.

Full dates (e.g. in reference to excavations) should be styled in the British manner: 22 September 2010.

Style for abbreviated units of measure is: figure space unit (e.g. 35 cm, 120 km). Abbreviated units of measure ordinarily have no punctuation of their own, unless this is standard (as in a.s.l.).

Decimals should be formatted in British style with point: 4.50.

Use a space between 'no./nos.', 'p./pp.', 'Fig./Figs.', 'pl./pls.' and following numbers.

Absence of information: use n.p. and n.d. for 'no place' and 'no date' respectively.

Bibliography

General Notes

Do not use dashes for repeated author names.

Capitalisation is used throughout in bibliographic referencing of English works, including sub-titles and article titles; specific conventions are used for works in other languages. For more general usage, please use traditional capitalisations, particularly for terms understood as specific designations of names. For example, use Ancient Egyptian or Bronze Age.

The bibliography should be given in roman script. Use a transcribed version of the reference where necessary. The original script can be included within square brackets. Single editor is 'ed.', multiple editors are 'eds.'.

Two or more authors are listed with comma separation.

For two firstnames or middlenames do not use space (e.g. Rossi, A.V.).

For two or more publication places use ordinary hyphen.

Please give only the scientific publishers.

References in the Text

References are in "Harvard style" and should be inserted inline: author's surname and year of publication, number of pages, fig. or pl. (e.g. Callieri 2018: 90, fig. 22).

The authors are listed with comma separation up to three ones. When four or more authors are listed, please use first author + et al. The full list of authors is required in the final bibliography.

Reference to series is restricted to numbered series. Non-numbered series are not noted. Publisher information is noted only in case of scientific one after the place of publication separated by colon:

Web-sites

Web-sites should be referenced by the particular web-page (or the most accessible page, possibly a home page), preferably followed by a date of consultation. Titles of pages/sites are acceptable for referring to web-sites:

following/s: f./ff. centimeter/s: cm

chapter: Chapt. column: Col. folio/s: Fol./Fols. translator: transl.

second [II] century: 2nd century, etc.

century and millennium: never abbreviated

before Christ: BCE after Christ: CE

plate/s: only when referring to author's plates within one's own text: Pl./Pls. figure/s: only when referring to author's figures within one's own text: Fig./Figs.

fig./figs., pl./pls. in all other cases
